## **THE PROGRAM**

The I.P.T.A. initiated its "*Transportation Emergency Assistance Manual*" (T.E.A.M.) in the mid-70's. Since its inception, many Iowa schools, their bus drivers, and hundreds of students have received out-of-district, emergency assistance, either directly or by referral to local service providers, by program member-schools and their staffs following a vehicle breakdown or other emergency situations. Member schools have provided assistance ranging from minor mechanical repairs to the loaning of school buses so that the disabled vehicle's driver and occupants could get to their destination safely and on schedule.

*NOTE: The names and information of persons listed in this directory are not necessarily the persons that will actually provide assistance; however, these people have agreed to help obtain the assistance you may need.*

## **THE COST:**

There is no fee for schools to be involved in this worthwhile program and it is not necessary that you be a member of the Iowa Pupil Transportation Association to be listed in the Transportation Emergency Assistance Manual. Any charges or costs associated with emergency assistance received or given are strictly between the persons, companies or districts involved. The I.P.T.A. is merely providing a public service for IPTA member schools, as directed in its by-laws, by gathering the names, addresses and phone numbers of persons willing to provide assistance and by publishing that information in this Transportation Emergency Assistance Manual.

Member School Districts may print the Transportation Emergency Assistance Manual or access it by using a Smart Phone or iPad. 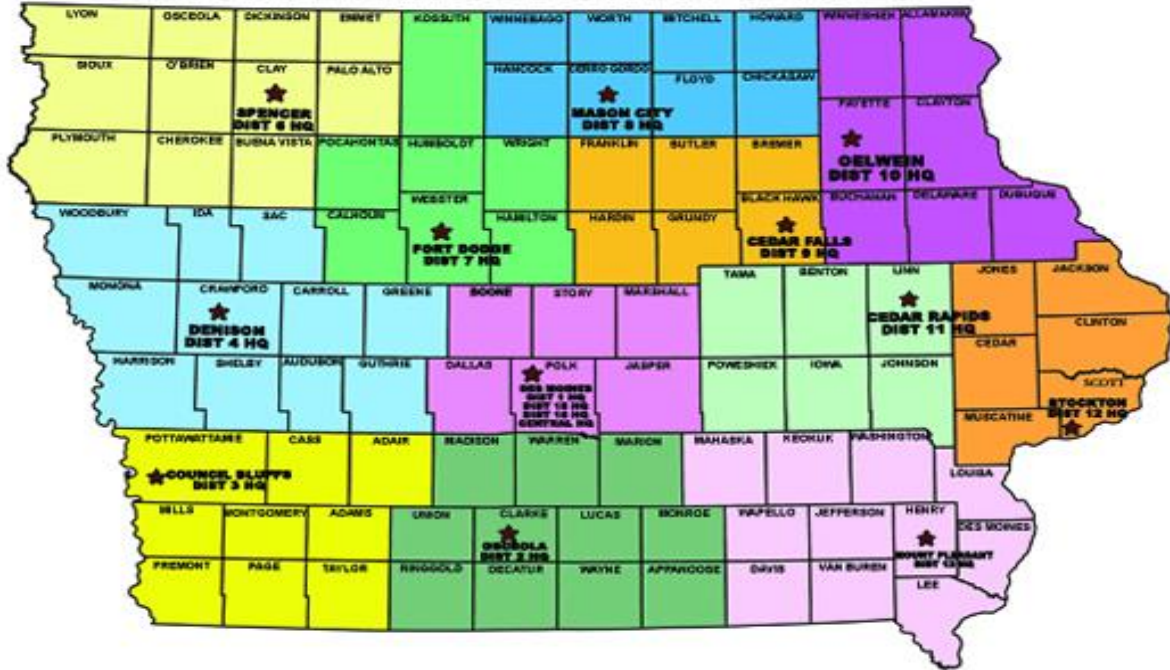
## **CHARGES FOR SERVICES:**

## **Post-Accident Drug & Alcohol Testing Requirement:**

The United States Department of Transportation and Federal Highway Administration Regulations require that **drivers of commercial motor vehicles (CDL holders)** be subjected to post-accident drug and alcohol testing when the following exists or occurs:

1. If you are involved in an accident in which a fatality has occurred on the bus or has occurred to a driver or passenger in other involved vehicles(s), you must submit to a drug and alcohol test.
2. Drug and alcohol testing is required if the driver of the bus has been issued a traffic citation **and** one or more of the following occurs:
  - a. One or more persons involved in the accident received bodily injury and received immediate medical treatment away from the scene of the accident
  - b. One or more motor vehicles involved in the accident incurred **disabling damage\*** requiring the vehicle to be transported away from the accident scene by a tow truck or other vehicle.

\* **"Disabling Damage"** means damage which precludes departure of a motor vehicle from the scene of the accident in its usual manner in daylight after simple repairs. This includes damage to motor vehicles that could have been driven but would have been further damaged if so driven. This does not include damage which can be remedied temporarily at the scene of the accident without special tools or parts such as: (1) tire disablement without other damage even if no spare tire is available; (2) headlight or taillight damage; or (3) damage to turn signals, horn, or windshield wipers which make them inoperative.

3. When a drug & alcohol test is required, the following regulations would apply:
  - a. Remain available to submit to a post-accident alcohol test within two hours and no later than eight hours after the accident.
  - b. Do not use alcohol for eight hours following the accident, or until the driver undergoes a post-accident alcohol test, whichever occurs first.
  - c. The driver must remain available and submit to a post-accident drug test for up to 32 hours following an accident.
  - d. Failure to remain available for post-accident drug and alcohol testing is considered a refusal to test and may subject the driver to discipline up to and including termination.
  - e. Post-accident drug and alcohol testing conducted by a law enforcement officer following an accident may not satisfy federal drug/alcohol testing requirements; therefore, the driver must remain available for post-accident testing by training personnel at an approved collection site.

## §382.303 - Post-Accident Test



- Any fatality involved – must test your driver for drugs & alcohol.
- No fatality and your driver is not issued a citation – No drug or alcohol test required.
- Driver issued citation and one of the following occurred – drug & alcohol test required.
  - *INJURY with Immediate Treatment Away from the Scene*
  - *TOWED VEHICLE due to Disabling Damage*

### **IMPORTANT: Required testing must be completed**

- (Alcohol) - within 2 hours of the accident or a maximum of 8 hours after which attempts to test stop.
- (Drug Test) – within 32 hours of the accident after which attempts to test stop.

**Note:** If unable to test within required time periods, you must document why it was not possible to test within the required time.
